Happy June! Now that Colorado 'May' is over, I'm sure we all are looking forward to the sunshine and summer plans! I would like to emphasize two key points as we move into the summer mode!

- 1. **House Remodeling/Maintenance:** When we plan any remodeling/maintenance project, we must submit the details to the Architectural committee for their review and approval to ensure there is no violation of architectural covenants or the harmony of the neighborhood. Since we are a covenant protected neighborhood, if there is a violation the HOA has the right to take legal action to safeguard our covenants and the neighborhood.
- 2. **RV/Trailer Parking:** We all enjoy fun camping trips with family and friends but please be aware of the city parking ordinance. We have seen and received complaints of RVs and trailers being parked on the streets for more than 24 hours and also blocking sidewalks.

o **54-464**:

- Do not park a truck more than 22 ft in length or a trailer not attached to a licensed vehicle for more than 2 hours on a public street
- Do not park a RV more than 22 ft in length, a truck and attached camper with combined length of more than 22 feet, or an auto/boat trailer attached to a licensed vehicle for more than 24 hours on street
- o **54-458**:
 - Do not park on the sidewalk or the sidewalk area

I'd also encourage all of you to report incidents/violations directly through 311 as it might take some time for the HOA board to receive the complaint and act.
