# **Expanded Waste Collection: From Councilman Kevin Flynn**

About a year ago, Denver City Council voted 8-5 (I was one of the no votes) to begin charging for trash services based on the size of the trash cart you use, with recycling and composting included in the price. The new program launched in January of this year.

Many of you have downsized your trash cans in anticipation of getting a compost cart for yard debris. Unfortunately, neighborhoods in Council District 2 may not get compost carts until 2024. I wish I could tell you more specifics. The fact is, while sending a press release July 10 announcing the first wave of compost cart distribution, the Department of Transportation and Infrastructure is not providing a timeline, only that District 2 "will be prioritized in 2024."

If you don't yet have weekly compost collection service, you will continue to receive a credit on your invoice. The credit will be removed once rollout is complete in your neighborhood. I realize, and have told the new Mayor Mike Johnston, that the summer lawn season is going to be a tough one without the compost carts for those who have downsized their trash carts.

I've also heard from several of the HOAs in the district that are being billed as one entity for trash services, rather than billing individuals based on the size of trash cart they have. DOTI has said the billing method for trash has to match the billing method for city's storm water fee. I don't agree with this billing practice and I'm working to address the issue.

The good news is DOTI reports diverting 2,443 more tons of recyclable material so far in 2023 compared to last year.
